



Ángela María Robledo Gómez (72)

has served as an Independent Member of the Board of Directors of Ecopetrol S.A. since March 2024. She is also Chair of the Board of Directors, Chair of the Territorial Transformation and HSE Committee, and Chair of the Compensation, Nominations, and Culture Committee. She is a Psychologist and holds a master's degree in social policy from Pontificia Universidad Javeriana in Bogotá.

She is currently part of the National Government's delegation in the peace negotiations in the Department of Nariño with the Comuneros del Sur Group.

She was a member of the Advisory Committee for the Development of the National Care System at the Ministry of Equality, and served on the National Participation Committee representing the

National Government in dialogues with the ELN.

Ms. Robledo Gómez served as a Member of the Chamber of Representatives of the Republic of Colombia, where she was a member of the First and Seventh Committees, served as Co-Chair of the Peace Committee, and was a member of the Gender Equity Committee of the same legislative body.

She has served as Advisor to the Rector's Office of the National Pedagogical University on Peace and Gender Affairs, an academic institution where she also worked as a tenured professor and researcher. She was also Academic Dean of the Faculty of Psychology at Pontificia Universidad Javeriana and a member of the Academic Council and the Superior Council of the same university, where she also served as a professor and researcher.

Additionally, she was a member of the District Cabinet during the mayoral administration of Antanas Mockus, serving as Director of the Administrative Department of Social Welfare of the District of Bogotá. She has also served as Social Director, Policy Manager, and Policy Coordinator for projects in the fields of health, education, rural development, and the rights of women, youth, children, and adolescents at the Antonio Restrepo Barco Foundation.

Based on the positions held throughout her professional career, Ms. Robledo Gómez has experience in: (i) energy transition; (ii) administration, senior management, and leadership; (iii) government and public policy matters; (iv) enterprise risk management; (v) human resources and talent development; (vi) legal and corporate governance matters; (vii) health, safety, and environmental matters; (viii) sustainability; (ix) human development in territories (territorial development); and (x) business strategy and project management.

As a member of the Board of Directors of Ecopetrol, she receives periodic training in ethics, compliance, and risk management.
